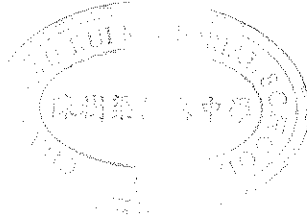

Flag-selling Day for the Community Chest of Hong Kong

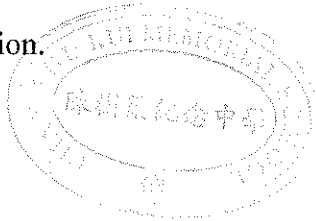
